Registration for any course can be completed in person or mailed to 101 Consumers Drive, Whitby and is on a first come basis. Enrollment is limited to a maximum of 25 persons per session. The Health Department reserves the right to cancel a session if there is insufficient enrollment. Please contact Health Department administration for registration at 1-888-777-9613.

Complete and submit this form along with a cheque or money order made payable to The Regional Municipality of Durham. If paying in person, exact cash only or Debit will be accepted. **DO NOT SEND CASH IN THE MAIL.** Registration and payment must be made at least four weeks in advance prior to the session you wish to attend. You will be registered in the course or exam challenge once full payment has been received. Your course manual will be provided to you at our office, can be mailed to the address on your form or downloaded at durham.ca under Food Safety training and certification. All attempts should be made to read through the material prior to attending the course.

Refund and Cancellation Policy

Due to limited space and course availability all course fees are non-refundable once a course session is booked and payment is received. However, if you are not able to attend your scheduled session and you provide a minimum 48 hours cancellation notice we can arrange upon request to put you on a waiting list for the next available session.
