5. Presentations

5.1 Alan Robins, Director of Housing Services, re: Durham Access to Social Housing (DASH) Waitlist

A. Robins, Director of Housing Services, provided a PowerPoint presentation with regards to Durham Access to Social Housing (DASH). A copy of the presentation was provided to Committee members.

A. Robins provided an overview of the legislative requirements for social housing. He stated that the DASH wait list is vacancy driven and provides a greater choice to applicants in deciding where they want to live in Durham. He advised that it determines initial eligibility, manages applicants, posts available vacancies to secure site and refers interested applicants to housing providers. He further advised that applicants must register to view and express their interest in vacancies. A. Robins provided an overview of the web page and demonstrated how applicants are able to view vacancies and express their interest in those vacancies.

A. Robins responded to questions with regards to how the service level standard is set by the province; clarification about the Canada-Ontario Housing Benefit; the effects of the Strong Communities Rent Supplement ending in 2024; ways to reduce the wait list; whether the service standards are reviewed yearly; whether the portable housing component will be made long term; encouraging use of the online tool to view vacancies; concerns about the number of families looking for

housing and issues surrounding those situations; and the possibility of looking into matching roommates.

Councillor Carter requested that he be provided with geographical information in relation to sheltered, unsheltered and primary source of income as listed under the DASH Applicant Information slide.

Councillor Pickles requested that he be provided with details regarding the number of people moving into Durham housing that do not reside in Durham.

4. Delegations

4.1 Susan deRyk, Interim President and CEO, Lakeridge Health and Rob Adams, CEO, Durham Mental Health Services re: Durham Mental Health Services and Lakeridge Health Pinewood - Proposed Amalgamation Plan

Susan deRyk, Interim President and CEO, Lakeridge Health and Rob Adams, CEO, Durham Mental Health Services provided a PowerPoint presentation regarding Durham Mental Health Services and Lakeridge Health. A copy of the presentation was provided to Committee members via email following the meeting.

S. deRyk and R. Adams stated that transforming local community mental health and addictions services requires removing barriers between providers and working as one team. They advised that an integration of the services offered by Durham Mental Health Services and Lakeridge Health will further improve the coordination of mental health and addictions services and care transitions to provide enhanced access, quality of care and better experiences of people. They further advised that an integration of services will remove barriers that exist between both organizations that prevent the seamless transfer of services and information.

R. Adams advised that they have created an online survey to engage the community and acquire feedback on the following four questions. He encouraged Committee members to submit their feedback through the online survey:

- What are we doing well now that should continue or be improved?
- What are the benefits you see as a result of the amalgamation?
- What unique features of both DMHS and Pinewood would you want to ensure are preserved or enhanced after amalgamation?
- Do you have any other considerations or advice that would be helpful?
- S. deRyk and R. Adams responded to questions of the Committee.
