4. Presentations

A) Aseem Malhi, Volunteer & Cavita Sharma, Save Soil Toronto Coordinator – Save Soil Awareness Presentation

Aseem Malhi, Volunteer & Cavita Sharma, Save Soil Toronto Coordinator, provided a PowerPoint presentation with regards to Save Soil Awareness.

5. Discussion Items

A) Rural and Agricultural Economic Development Update

S. Jibb provided the following update:

- Ontario's Rural Economic Development Program will open on January 23, 2023. The Program provides an opportunity for rural communities and non-profit organizations to apply for funding for projects that improve rural communities from an economic development standpoint. There may be a request for letters of support from DAAC at the next meeting.
- Working on the business toolkit for farms looking to diversify into onfarm diversified uses, which is currently in phase two, and will have a draft plan available in the coming months.

A. De Vos provided the following update:

- Looking for ways to offer agri-tech support to Durham College for companies that are testing technology on their urban farm in Ajax, through companies the federal government is working with.
- Durham Farm Connection's Annual General Meeting is being held on January 24, 2023 in Blackstock.

Discussion ensued with regards to agriculture education within the toolkit.

B) Agriculture 101 Training

S. Jibb advised that at the recent subcommittee meeting, they received feedback on the draft presentation that will be incorporated, and plan to present to Regional Council before Spring 2023.

- C) Impacts on Food Prices and Opportunities for Advocacy to Improve Financial Viability for the Agri-food Sector
 - S. Jibb advised that the resolution below stemmed from discussion at Z. Cohoon's presentation to the Planning and Economic Development Committee on January 10, 2023 regarding the DAAC 2022 Annual Report.

Moved by D. Risebrough, Seconded by B. Smith,
That the following recommendation be forwarded to the Planning and
Economic Development Committee for approval and subsequent
recommendation to Regional Council:

Whereas the agri-food industry is one of the top economic drivers in Durham Region supporting a workforce of over 27,105 people through 3,360 agri-food businesses, more than 1,200 farms and farm families, contributing upwards of \$354 million to Ontario's total farm production and supporting \$775 million in GDP;

And Whereas food prices have seen their steepest increase since 1981 with a year over year increase of 11% as of October 2022;

And Whereas inputs for farmers and primary producers have increased significantly in the last year, including fertilizer prices increasing 95.8% compared to July 2020, fuel prices have seen a historic year-over-year increase, while chemical/herbicide markets have experienced shortages and increased prices. Despite these changes, farmers have not seen a significant increase in their primary product price to compensate for the rising cost of inputs;

And Whereas the profit margin for farmers was adversely impacted by a 35% tariff placed on fertilizer imports, including fertilizer purchased prior to economic sanctions being placed on Russia and Belarus that farmers in Canada rely on to support food production.

Now therefore be it resolved that the Durham Agricultural Advisory Committee requests that Regional Council recognize the importance of agriculture in Durham Region by encouraging the federal government to compensate farmers for tariffs paid on fertilizer, one of the contributing factors to increased food costs.

 - S. Jibb advised that Z. Cohoon presented to the Planning and Economic Development Committee on January 10, 2023 with regards to the DAAC 2022 Annual Report. Z. Cohoon advised he asked Committee members to support Durham Region on the tariff issues, food prices, and fertilizer.

Discussion ensued with regards to educating and communicating agriculture awareness to Regional Council.

E) <u>2023 Farm Tour Preliminary Discussion</u>

Discussion ensued with regards to potential site locations and potential dates for the 2023 DAAC Farm Tour.

It was the consensus of the Committee that a Farm Tour Sub-Committee be formed consisting of D. Risebrough, B. Smith, K. Kemp, T. Watpool, and T. Barrie.
