6.1 Geoff Carpentier, Chair, Durham Environment and Climate Advisory Committee, and Jay Cuthbertson, First Vice-Chair, Durham Environment and Climate Advisory Committee, re: Perennial/Pollinator Plots Pilot [Item 9.1 a.]

Geoff Carpentier, Chair of Durham Environment and Climate Advisory Committee, participating in-person, and Jay Cuthbertson, First Vice-Chair of Durham Environment and Climate Advisory Committee, participating virtually, appeared before the Committee regarding a Perennial/Pollinator Plots Pilot entitled: Rethinking how we maintain our roadside and public spaces.

- J. Cuthbertson stated that the purpose of their delegation was to speak about an alternate approach to maintain roadsides and public spaces which would lower costs, increase biodiversity and beauty in the area while sequestering carbon, and improving surface water management. He advised that pollinators are in an unprecedented crisis position globally and different approaches to how roadside and public spaces are maintained will assist in mitigating this crisis.
- G. Carpentier provided a brief overview regarding how changing how roadsides and public spaces are maintained would benefit the Region.
- G. Carpentier stated that the Durham Environment and Climate Advisory Committee is asking that staff initiate a study and pilot project to change the way roadside and public spaces are maintained, to expand pollinator gardens throughout the Region, to consider how much and when to mow lawns, and to look to other agencies and municipalities for guidance.

G. Carpentier and J. Cuthbertson responded to questions from the Committee.
