A) Durham Food System Report Card, Mary-Anne Martin, Durham Food Policy Council

M-A. Martin responded to questions from the Committee regarding whether the data that they collected from 2015 was the most up-to-date data available; and what the percentage was of individuals living in Durham Region that were food insecure from 2018 to 2022.

## 6. Items for Action/Discussion

## A) Spring Pollinator Project Update (A. Lugman)

A. Luqman thanked the Committee members that helped to pack the seed packets, with a special thanks to K. Murray and her students who packed 1,000 seed packets. She advised that 3 compost giveaway events have occurred (Town of Ajax, City of Oshawa, and the Township of Brock), and that 5 events remain.

# B) Tour of McLaughlin Bay and Second Marsh Update (A. Luqman)

A. Luqman advised that on Monday, May 13, 2024, G. Carpentier, O. Chaudhry, S. Ciani, and herself, attended a guided tour by P. Taylor, President, Friends of Second Marsh, and A. Groen, Oshawa Environmental Advisory Committee (OEAC) of the McLaughlin Bay and Wildlife Reserve and Second Marsh. G. Carpentier noted how forward thinking the Friends of Marsh are, and that they look to promote a healthy environment through education, communication, developing partnerships, and fostering connections with all sectors of the community.

C) Ontario Energy Board (OEB) Decision on Enbridge Gas 2024 Rate Application and Bill 165 – Keeping Energy Costs Lower Act (I. McVey)

A copy of Report #2024-A-7: December 2023 Ontario Energy Board (OEB) Enbridge Gas Inc. decision and proposed amendments to the Ontario Energy Board Act, 1998 and the presentation to Regional Council on April 24, 2024, was received.

In I. McVey's absence, N. Halim advised that Report #2024-A-7: December 2023 Ontario Energy Board (OEB) Enbridge Gas Inc. decision and Proposed Amendments to the Ontario Energy Board Act was presented to Regional Council on April 24, 2024, and approved. He advised that the report summarized the implications of the OEB's decision.

# D) Durham Mechanicals Technology (Heat Pump) Forum – June 5, 2024 (I. McVey)

In I. McVey's absence, N. Halim informed the Committee of an upcoming event being hosted by Durham Region's Home Builders Association (HBA) that will be focused on mechanical systems, best practices for the sizing, selection and design of hybrid heating combination space and water heating systems (ex. heat pumps), and other low carbon efficient systems. He advised that there will be a roster of guest speakers that are industry experts and that there is a registration fee.

N. Halim responded to a question from the Committee regarding the cost of a heat pump and what is the strategy for retrofitting homes with a heat pump as opposed to new builds where they are installed from the start.

# E) Fall Durham Climate Forum

Discussion ensued regarding whether the Committee would be interested in participating in the Fall Durham Climate Forum, even though there would not be an Environmental Awards component, as the awards occur every two years.

A. Luqman advised that Durham staff have met with Ontario Tech University to brainstorm what the event could look like (venues, dates, etc.). Staff are looking to offer a more broad, animated, and family-friendly event that would include David Suzuki's Foundations Art and incorporate a cultural aspect.

It was the consensus of the Committee that they would like to participate in some capacity. Discussion ensued regarding forming a subcommittee to brainstorm further ideas before the June DECAC meeting. K. Murray expressed an interest in participating.
