10.1 Notice of Motion re: Cannabis Use in Public Places

Councillors Roy and Chapman gave notice that they will present the following motion regarding cannabis use in public places:

That we recommend to Council:

- a) Whereas the use of cannabis became legalized in Canada on October 17, 2018; and
- b) Whereas every time cannabis is used it can adversely affect learning and remembering, mental health, and mood and feelings; and
- c) Whereas regular cannabis use over a prolonged period of time can injure the lungs, adversely affect mental health, and lead to physical dependence or addiction; and
- d) Whereas cannabis use in public places combined with its known health effects can adversely affect community safety, such as through impaired driving, etc.; and
- e) Whereas Section 11 of Schedule 1 (*Cannabis Act, 2017*) of *The Cannabis, Smoke-Free Ontario and Road Safety Statute Law Amendment Act, 2017*, S.O. 2017, c. 26 – Bill 174 prohibited the use of cannabis in public places; and
- f) Whereas Section 11 of Schedule 1 (Amendments to the Cannabis Act, 2017 and Other Acts) repealed Section 11 (Restrictions on places of consumption) of the *Cannabis Act, 2017*; and
- g) Whereas Section 12 of the *Smoke-Free Ontario Act, 2017* prohibits the smoking or holding of lighted cannabis in only enclosed public places and workplaces; and

- h) Whereas it is desirable to mitigate the human health effects of cannabis use and to de-normalize the use of cannabis in all public places, particularly with respect to children and youth; and
- i) Whereas it is also desirable to mitigate the community safety impacts of cannabis use in all public places;
- j) Now therefore be it resolved that the Council of the Regional Municipality of Durham urges the Government of Ontario to amend the *Smoke-Free Ontario Act, 2017* such that the smoking or holding of lighted cannabis is prohibited in all public places; and
- k) Now be it further resolved that the Councils of Durham's lower-tier municipalities are requested to endorse this resolution; and
- l) Now be it further resolved that the Premier of Ontario, Deputy Premier & Minister of Health and Long-Term Care, Attorney General of Ontario, Minister of Finance, Durham's MPPs, Chief Medical Officer of Health, AMO, alpha and all Ontario Boards of Health be so advised.

**2. Election of Health and Social Services Committee Vice-Chair**

The Chair asked if Councillor Pickles wished to stand. Councillor Pickles indicated he would stand.

Chair Chapman declared Councillor Pickles the Vice-Chair of the Health & Social Services Committee.

**5. Presentations**

**5.1 R. MacEachern, Manager, Health Protection, re: Smoke-Free Ontario Act, 2017 and Regional By-Law**

R. MacEachern provided a PowerPoint Presentation with regards to the Smoke-Free Ontario Act, 2017 and Regional By-Law. A copy of the presentation was provided as a handout.

R. MacEachern stated that on October 17, 2018, the Smoke-Free Ontario Act, 2016 and the Electronic Cigarettes Act, 2015 were repealed and replaced with the Smoke-Free Ontario Act, 2017 (SFOA, 2017). He stated that the SFOA, 2017 regulates the sale, supply, display and promotion of tobacco and vapour products as well as the smoking of tobacco, the use of e-cigarettes to vape any substance and the smoking of medical cannabis. He further stated that the regulation of other cannabis related activities are addressed in other statutes including the Cannabis Act (Canada) and the Cannabis Control Act, 2017 (Ontario). New provincial regulations regarding private recreational cannabis store systems will begin on April 1, 2019 under the oversight of the Alcohol and Gaming Commissioner of Ontario (AGCO).

R. MacEachern advised that the following are new amendments under the SFOA, 2017:

- Expands restrictions on smoking of tobacco and use of e-cigarettes to vape any substance;
- Regulates smoking of cannabis and all methods of consuming cannabis in vehicles and boats;
- Strengthens display and promotion restrictions relating to tobacco products;
- Creates the display and promotion rules for vapour products;
- Requires a tobacconist to register with its local board of health to display and promote specialty tobacco products; and
- Requires a specialty vape store to register with its local board of health to display and promote vapour products.

R. MacEachern stated that public health units are expected to employ a progressive enforcement approach for the new amendments in the SFOA, 2017 but will continue with a zero-tolerance policy regarding the sales of tobacco and e-cigarettes to minors. He provided an overview of various occurrences with regards to cannabis use and the corresponding legislation and jurisdiction that would apply.

R. MacEachern advised that recreational cannabis became legal for adults in Canada on October 17, 2018 and reviewed various statistics in relation to cannabis. He also advised that 40 million dollars over the course of 2 years has been committed by the provincial government to help municipalities with the implementation costs of the legalization of recreational cannabis. He further advised that municipalities can inform AGCO of their decision to opt out of hosting retail cannabis stores by January 22, 2019 or they are considered to have opted in.

R. MacEachern advised that vaping is the use of a vaporizer or inhalant device that heats up a substance that produces a vapour. He advised that there is no strong evidence that shows vaping as an effective tool to stop smoking and it could take years to determine the health effects.

R. MacEachern stated that the current Regional Smoking By-law was passed on December 4, 2002 and needs to be replaced with a new by-law that regulates smoking and vaping in public places and in the workplace. He provided an overview of what the new By-law will include.

R. MacEachern responded to questions and discussion ensued with regards to whether the area municipalities have been contacted regarding the changes to the SFOA 2017; the importance of regulating the use of cannabis in public areas in the same manner as alcohol; whether there may be potential problems with some municipalities opting out and some not opting out to host retail cannabis stores; and the importance of providing proper education with regards to vaping.

5.2 Dr. H. Drouin, Commissioner of Social Services, re: Social Services Department Overview and Orientation

---

Dr. Drouin, Commissioner of Social Services, provided a video and PowerPoint presentation regarding the Social Services Department. A copy of the presentation was provided as a handout.

Dr. Drouin stated that the Department's mission statement is "to meet the needs of citizens through leadership, cooperation and service excellence". He stated that the Department's principles are: care; excellence; learning; and leadership. He also advised of the following strategic priorities: sustaining a culture of excellence; strengthening the capacity to meet emerging trends; ensuring value of the department and its services; and building the capacity to collaboratively respond to emerging social issues. Dr. Drouin stated that in November 2018, the Department received the Canada Awards of Excellence Gold Award for the Excellence, Innovation and Wellness (EIW) Standard.

An overview was provided of the following Social Services Divisions:

- Commissioner's Office
- Business Affairs and Financial Management
- Children's Services
- Family Services

- Housing Services
- Income and Employment Support
- Long Term Care and Services for Seniors

An overview was also provided of various community needs and challenges.

Discussion ensued with regards to possible changes being implemented by the provincial government and best methods for committee members to assist with inquiries and concerns from citizens regarding various issues.
