A) Complaint Regarding DRT Buses Speeding on Coldstream Drive, City of Oshawa

Commissioner John Neal raised a concern that was brought to his attention by a resident regarding DRT buses speeding on Coldstream Drive in the City of Oshawa. He advised this has been an issue for quite some time and asked staff how this was being addressed.

B. Holmes advised that staff is investigating this complaint and will respond accordingly if it turns out to be a performance issue with the operator. He further stated they have committed to looking at this issue in more depth with Durham Regional Police Services to monitor speeds in this area.
