Recommendations:

That the Planning and Economic Development Committee recommends to Regional Council:

- A) That the following citizen volunteer be appointed as the Township of Scugog's **Area Municipal Representative** to the Durham Agricultural Advisory Committee: Kevin Kemp;
- B) That the following citizen volunteer be appointed as the Township of Scugog's **Area Municipal Representative** to the Durham Environmental Advisory Committee:

 Geoffrey Carpentier;
- C) That the following citizen volunteers be appointed as **At-Large** members to the Durham Environmental Advisory Committee: Keiko Lui and Dennis Sallans;
- D) That the above-named citizen volunteers be advised of their appointment to the respective Advisory Committees; and

E) That a copy of Commissioner's Report #2019-P-14 be forwarded to the area municipalities.

Report:

1. Purpose

1.1 On March 5, 2019, staff brought forward Commissioner's Reports #2019-P-10 and #2019-P-11 related to the appointment of citizen volunteers to the Durham Agricultural Advisory Committee (DAAC) and Durham Environmental Advisory Committee (DEAC), respectively. Both reports noted there were a few Committee vacancies that still needed to be filled. The purpose of this report is to recommend additional citizen volunteers to serve on these Advisory Committees.

2. Membership Nominations/Appointments

Durham Agricultural Advisory Committee

2.1 On March 11, 2019, the Region received correspondence from the Township of Scugog (see Attachment 1) related to its citizen volunteer appointment for DAAC. It is recommended that the following citizen volunteer be appointed as the Township of Scugog's "area municipal representative" to the Durham Agricultural Advisory Committee: Kevin Kemp.

Durham Environmental Advisory Committee

- 2.2 On March 11, 2019, the Region received correspondence from the Township of Scugog (see Attachment 1) related to its citizen volunteer appointment for DEAC. It is recommended that the following citizen volunteer be appointed as the Township of Scugog's "area municipal representative" to the Durham Environmental Advisory Committee: Geoffrey Carpentier.
- 2.3 In accordance with the DEAC Terms of Reference, the Planning and Economic Development Committee recommends five additional "at large" members. Three of the five "at large" members were recommended through Commissioner's Report #2019-P-10. Following a review of the remaining applications, it is recommended that the following citizen volunteers be appointed as "at large" members to the Durham Environmental Advisory Committee: Keiko Lui and Dennis Sallans.

2.4 The applications of individuals who expressed interest in serving on the committees who were not chosen are retained for consideration in the event of a future vacancy.
