The proposed plan by OPG and the Independent Electricity Operator is that Units 1 to 4 will operate until 2024 as permitted under the current Canadian Nuclear Safety Commission (CNSC) Operating Licence, while Units 5 to 8 would operate until 2025. OPG would need to seek regulatory approval from the CNSC in order to operate Units 5 to 8 to 2025 through a public hearing process.
