4. Discussion Items

A) Rural and Agricultural Economic Development Update – S. Jibb

S. Jibb advised of the following:

- The Local Food Hub and Agri-Food Innovation Centre is currently in the conceptual stage and staff is exploring the idea of establishing the Centre in Durham Region.
- The Local Food Business Retention and Expansion Project was approved in May 2019 and the actions are underway. An Information Report will be going to the October Planning and Economic Development Committee meeting.
- Durham Farm Fresh will be hosting an upcoming webinar on Ontario by Bike.

A. Brown advised of the following:

- With regards to the abattoir investment opportunity, A. Brown advised that she has met with regional works staff to understand the servicing requirements and will be following up with the investor in mid-September.
- Staff has developed agriculture and local food focused messages for use with a social media calendar for the Township of Scugog.
- With regards to the Oshawa Port Grain Terminal, a discussion was had with Michael Pearce of Hamilton-Oshawa Port Authority, who expressed an interest in providing another delegation in early 2021 once they have more grain vessels go through the port and have a large sample size to get feedback from. One current challenge is the lack of on-site storage for grain.
- The Emily Project will be rolling out across the Region over the coming months and will be fully funded by the Region to assist local area municipalities with purchasing and installing green number signs. Staff is working with the development of a communications plan.

B) <u>DAAC Farm Tour – D. Risebrough</u>

Discussion ensued with regards to the final product of the Virtual DAAC Farm Tour.

K. Allore-Engel provided the following comments:

- Approximately 170 registrants have registered to view the Virtual Farm Tour;
- Registrants will be provided with an email link and password on the morning of the Tour;
- After the Tour, there will be a prompt to complete a survey; and
- The number of views will be tracked.

Further discussion ensued with regards to the possibility of sharing the video for educational purposes and the best way for committee members to respond to questions asked about the Virtual Farm Tour.

Report:

1. Purpose

1.1 The purpose of this report is to provide an overview of the 18th annual Durham Agricultural Advisory Committee (DAAC) farm tour event which was held virtually on September 17, 2020.

2. Background

- 2.1 Since its inaugural tour in 2003, DAAC has showcased more than 40 farms and other agricultural facilities across Durham Region to more than 1,300 participants.
- 2.2 Due to COVID-19, DAAC was not able to offer the same in-person experience this year. However, this year's event presented a unique opportunity to virtually tour two facilities not available to the public due to bio-security protocols.

3. Event Overview

3.1 Over 150 participants representing municipal and provincial governments; public agencies including conservation authorities, school boards, post-secondary institutions; municipal advisory and economic development committees; the

financial and insurance industry; the agricultural community; and media attended the annual event. The tour highlighted the importance of Durham's diverse agricultural sector, as well as some of the issues and challenges faced by the industry.

- 3.2 The theme for this year's tour was "Virtual Spotlight on Agriculture in Durham Region". A variety of topics were covered including: growing/producing custom animal feed, technology and equipment used, information about bio-security, and animal husbandry at an egg laying operation and a hog operation.
- 3.3 Regional Chair and CEO, John Henry welcomed attendees to the virtual event, while a photo montage from previous tours was displayed. Chair Henry spoke about:
 - The important contributions of the agriculture industry in Durham;
 - How agriculture is one of the top goods producing sectors in Durham Region and a major economic driver;
 - The diverse range of agricultural commodities in Durham, from grain and cattle, to poultry and hogs, to apples and nursery trees;
 - How many family farms have been operational for over 150 years while others are just entering the business; and
 - How Durham's more than 1,300 farms continue to enrich our communities and lead our agriculture and food sector to success.
- 3.4 DAAC Chair, Zac Cahoon presented history on the Committee and introduced the farms being toured for this event. Chair Cahoon spoke about:
 - Farmers resiliency to change and adversity;
 - How DAAC had to adapt and transitioned this year's farm tour to a virtual video format;
 - How the farms featured this year are not normally accessible for inperson tours due to bio-security reasons;
 - Bio-security at the farm level is defined as management practices that allow producers to prevent disease-causing agents to enter the farm property;
 - Livestock health because of strict adherence to rigid bio-security measures results in safe and high-quality food, that starts right on the farm.

- 3.5 The virtual farm tour portion included an inside look into the following operations:
 - a. Hubert Schillings White Feather Farms Inc. Mr. Schillings gave participants a tour of his egg laying facility and provided information on high quality homemade feed, importance of bio-security on the farm, salmonella testing for food safety and the role of technology. A video included footage of a modern barn, housing enrichment (i.e. perches and scratch pads), and the egg sorting/packing machinery.
 - b. **Tom Watpool Watpool Farms Ltd.** Mr. Watpool gave participants a tour of his hog operation and provided information on the breeding process, piglet welfare (i.e. heat lamps and mats), the nursery environment, different phases of feed depending on the age of the pig, the importance of social hierarchy, the use of environmental controls (i.e. sprinklers, fans, feed and water) and the importance of bio-security to be able to raise pigs free of antibiotics. A video included footage of the barn, pigs of different ages, the feed milling process, the use of technology and the importance of bio-security.

4. Event Feedback

- 4.1 Each year, participants are asked to complete a survey that is used by DAAC to evaluate the success of the tour and to help plan for future events. This year, an electronic survey was distributed following the virtual farm tour. From the 65 responses received, almost all agreed that the tour met or exceeded their expectations. Some general comments were:
 - It exceeded my expectations.
 - It was great to access farm operations that would normally be off-limits on an in-person tour.
 - Important information for us to know about our community farmers.
 - This information is very informative in terms of understanding the different farming operations in Durham.
 - It's important to educate the public that farming utilizes science to be stewards of the land, incorporating new technologies.
 - Supporting our farmers and creating environments for education is vital.
 - Modern farms are complex environments that ensure a safe and healthy environment.
- 4.2 Participants were asked what the "Take Home" message was for them. Responses included:

- Durham Region farms are a top economic contributor to the region and the province.
- Durham Region farms operate sustainably and can be vertically integrated.
- Animals are well-cared for, and there is a high level of concern for the safety of the animals and for the consumer.
- The importance of a clean and sanitary environment.
- Thank you for the hard work and dedication to the community and agriculture and food industry!
- Lots of good work taking place in Durham! Being in the city, we tend to forget there's an entire agricultural sector in Durham.
- How fortunate we are to live within a region with such diversity of production and quality farming practices.

5. Conclusion




Q1 Have you attended an "in person" DAAC Farm Tour before?

Q2 Did the virtual DAAC Farm Tour meet your expectations?



To all Temporary Foreign Worker Employers:

COVID-19 outbreak management on farms in Ontario has been an ongoing challenge that has required collaboration from all levels of government and agricultural stakeholders. Farm-associated COVID cases have been linked to 30 outbreaks and have accounted for 3% (1,364) of all cases reported in Ontario. Temporary foreign workers (TFWs) are particularly vulnerable to COVID infection due to their congregate living settings and other risk factors. COVID outbreaks have shown to spread quickly in congregate living settings such as bunkhouses. It is important to remain vigilant and take every precaution necessary to prevent the entrance of COVID-19 into your workplace and housing accommodations.

The Ministry of Health and Durham Region Health Department recommend that enhanced housing standards be considered to ensure physical distancing (at least 2 meters) and self-isolation is achievable throughout the agricultural season to avoid transmission in TFW housing accommodations. This would include avoiding the use of bunk beds, decreasing bed capacity if necessary to enable 2 metres distancing, limiting the number of people sharing washrooms and changing furniture placement to allow 2 meters distancing.

We strongly urge you to review your existing migrant farm accommodations and consider whether modifications are required in order to be able to follow public health guidance. There has been a great deal of discussion at all levels of government regarding improving housing standards for migrant worker accommodations and new requirements may be implemented sooner rather than later if additional public health measures need to be taken to curb the rise in COVID cases associated with TFWs. Please be sure to contact your local building and fire departments prior to commencing any renovations to ensure compliance with the Ontario Building Code and Ontario Fire Code. If you have any questions relating to your current accommodations, please contact your public health inspector who will be able to assist in reviewing the TFWs housing and provide recommendations to help maintain physical distancing.

Information regarding funding opportunities which included \$15 million to help enhance health and safety measures in the workplace as well as housing accommodations was sent to all operators on August 4th. Many resources have also been developed to assist agricultural enterprises such as the <u>Agri-Food Sector Workplace Safety Toolkit</u> which contains a "one stop shop" for farmers on guidance, resources and information related to prevention, control, testing and outbreak management supports.

I would also like to take this opportunity to remind you that the <u>Class Order</u> issued by Dr. Kyle, Commissioner & Medical Officer of Health for the Regional Municipality of Durham on June 24th to protect the health of Canadians and Temporary Foreign Workers and prevent an outbreak of COVID-19 at any of our farms locations is still in effect.

Dear Mr. Mayor

My wife and I own and operate Link Greenhouses. Covid is and has been challenging for all of us. Currently rumor has it that the health department is going to make a decision on next years migrant workers accommodations. When these guys come up they go into two weeks of isolation with social distancing of 2 meters even in the bedrooms. Rumour has it that when they come out of isolation they will need to maintain two meters social distancing and that bunk beds will no longer be allowed. Remember that once they come out of isolation they are healthy and don't leave the property, they work and live like a family, which means very little chance of getting infected by covid 19. IF the health department would to implement the No bunk bed rule and two meter distance rule in the bunkhouses this will be a large financial impact for a lot of farmers. Therefore I ask from you if possible speak with the health department and try to work with previous rules on sleeping accommodation. Currently our bunkhouse can hold 10 guys in three bedrooms with two full bathrooms, two stoves and 4 fridges. If the no bunk bed rules and two meter distance rules come into effect we can only accommodate 5 guys. We are all in this together and we certainly don't want to see any farms disappear due to migrant workers housing issues. One migrant worker = 2,1/2 spin off jobs Regards Henk Mulders 905-718-0076

Re: Food Industry Worker Day

The following resolution was passed by Ajax Town Council at its meeting held September 21, 2020:

WHEREAS World Food Day – an international day to take action against hunger and to advance healthy diets for all – is observed by 150 countries around the world on the third Friday of October (close in timing to Thanksgiving traditions in Canada), and is celebrating its 75th anniversary on October 16, 2020; and

WHEREAS As countries around the world come to terms with the health, social and economic damage caused by the COVID-19 pandemic, we have a renewed sense of understanding about how important national and locally-grown food supplies are, as grocery stores remained stocked with nutritious food options for Ajacians; and

WHEREAS The week of Thanksgiving allows Ajacians an opportunity to reflect on our great fortune to live in a country and province where local food is available year-round, but we must not lose sight of those who sacrifice to ensure that local food is planted, cultivated, harvested, processed and distributed; and

WHEREAS The agri-food industry employs almost 8,000 people in Durham Region alone, relies on approximately 600 seasonal agricultural workers, and directly impacts a further 25,000 people employed in food services (including grocery stores and restaurants); and

WHEREAS The direct and indirect economic impact of the agri-food industry is significant across the Region. According to Statistics Canada (2016), the average household in Durham Region spends almost \$1,000 every month (11% of average household income) on food consumption, and over 200 farms in Durham Region report direct to consumer sales; and

WHEREAS Food industry workers endure tough working conditions including long hours, precarious and/or seasonal labour availability, and essential status through crisis events, like COVID-19, that directly put people in factories, in dorms or working in close proximity at risk;

THEREFORE, BE IT RESOLVED THAT

- 1) Ajax Council formally marks the 75th anniversary of World Food Day by proclaiming the Friday after Thanksgiving (October 16, 2020) as Food Industry Workers Day in Ajax, acknowledging with gratitude the sacrifices made to ensure we have abundant food available in our grocery stores and farmer's markets, maintaining healthy and fresh food options for Ajacians throughout the COVID-19 crisis and every day; and
- 2) That this resolution be distributed to Durham Regional Council, Durham Agricultural Advisory Committee, Durham Region MPs and MPPs, the Minister of Agriculture and Agri-Food, Ontario Minister of Agriculture, Food and Rural Affairs, and the Ontario Minister of Labour, Training and Skills Development

Dear Mr. Henry:

Over the past 2 years, our government has heard from farmers, municipalities and the broader agriculture community about the threat of on-farm trespass activities. We have heard that farmers are worried for their own safety, the safety of their families, their employees as well as the safety of their animals.

We listened to your concerns, and back in December 2019, I was honoured to introduce the <u>Security from Trespass and Protecting Food Safety Act, 2020</u> and to act on our government's commitment to protect farmers, agri-food businesses, farm animals and our food supply from the risks of trespass activities. The Act received Royal Assent on June 18, 2020.

I appreciate the strong support that I have received from our stakeholder partners, like you, on such an important piece of legislation. The COVID-19 outbreak has shown us now more than ever, how important it is to have a steady, reliable food supply and to protect the health and safety of the agri-food workers who help feed us.

As you may be aware, we have recently seen a public safety situation grow more urgent. Earlier this summer a demonstrator tragically died outside a meat processing plant. Since then, we have seen heightened tensions leading to greater risks for everyone involved. This has created a significant public safety concern that must be addressed to ensure everyone's safety.

As a result, I am announcing today a partial proclamation of the <u>Security from Trespass</u> and <u>Protecting Food Safety Act, 2020</u> that will come into effect on Wednesday September 2, 2020 at 12:01AM to address these immediate public safety concerns.

Good things grow in Ontario À bonne terre, bons produits We are proclaiming sections 6(1), 7, 14(1)[3] and 15(1) of the Act, making it an offence to stop, hinder, obstruct or otherwise interfere with a motor vehicle transporting farm animals.

Regulation 950 under the <u>Provincial Offences Act (POA)</u> is also being amended so that tickets can be issued under Part I of the POA for a contravention of section 6(1) of the Act. This approach will allow for more immediate use of the relevant provisions to address the obstruction of motor vehicles transporting farm animals.

I am also pleased to inform you that a <u>Discussion Paper</u> has been posted on the regulatory registry, outlining the ministry's proposed approach for the regulatory items that are needed to make the rest of the Act come into force. It will be posted for public comment for 45 days, closing on October 15, 2020. Comments can also be sent directly by email to <u>SecurityFromTrespass.OMAFRA@ontario.ca</u>.

I understand the importance and urgency of this Act to many across the sector. However, before the remaining sections can be proclaimed into force, a number of items must be prescribed via a regulation to operationalize the Act. These regulations are needed to ensure the act is clear, easily interpreted and fulfils its intended purposes. It is important that we take the time to hear from those impacted so we can take those comments into consideration in finalizing the regulation.

The remaining sections of the Act come into force upon proclamation by the Lieutenant Governor in Council. Once fully proclaimed into force, the Act will recognize the unique risks associated with trespassing on farms and at processing facilities.

I strongly encourage you to provide feedback and comments on this discussion paper. Your insights are valuable as we work to ensure the Minister's Regulation and the Act are fair and reasonable while also meeting the needs of industry. Your input is an important contribution to help shape the content and design of the Minister's Regulation.

Again, thank you for your support. I look forward to working with you to create a safe and healthy Ontario for all.
