5.1 <u>John Colligan, Durham Resident re: NSF Water Billing Charge</u>

John Colligan, Durham resident, appeared with respect to a Non-sufficient Funds (NSF) charge on his water bill.

- J. Colligan advised that he received a large water bill which he paid on the MyDurhamWater portal. He stated that because he paid through the portal, the payment was delayed coming out of his bank account. He added that he subsequently moved money out of the bank account believing that the bill had already been paid, and therefore there was not enough funds remaining for the water bill payment.
- J. Colligan advised that as a result of the bill payment not coming out of his account as quickly as expected and the funds not being available when it did, he incurred an NSF charge of \$48 from the Region, along with a charge of approximately \$50 from his financial institution.
- J. Colligan advised that he contacted the Region's water billing division to ask for a reversal of the charge and he was requested to send details of his complaint via email. He was then told that the charge could not be reversed.
- J. Colligan contacted other members of staff and Council in an attempt to have the charges reimbursed.
- J. Colligan requested that the Committee approve a good will reversal of the \$48 NSF charge.
- J. Colligan responded to questions from the members of Committee.
